Senator Marshall asked at *Hansard* pages 108 and 109:

Further to QON W556-06 from the previous Estimates, can the Office please update the data provided in the answer to take in to account what has occurred since the previous Estimates round.

QON W556-06 refers to data request to the following categories:

- I. For people under the ages of 2l, 18 and 15;
- II. Give the monthly breakdowns of the last 6 months; and
- III. Identify them by Industry Sector.

Answer:

- a) AWAs approved in the financial year so far (July 2005 February 2006):
 - AWAs approved for persons aged greater than or equal to 18 but under the age of 21 (i.e. < 21, but 18+ yoa): 11497
 - AWAs approved for persons aged greater than or equal to 15 but under the age of 18 (i.e. < 18, but 15+ yoa): 6702
 - AWAs approved for persons under the age of 15 (i.e. < 15): 513

It should also be noted that the AWA approval figures are not cumulative i.e. < 21 years of age does not include figures already disclosed for the <18 and <15 years of age categories.

b) AWAs approved for persons under the ages of 21, 18 and 15 per month, for the previous 6 months (end of February 2006).
