Please provide a breakdown of available information on the classification of job seekers within Job Network services at a point in time and the numbers in each of those categories to include the \$97m reduction in 07-08 as well.

Answer:

Attachment A provides a breakdown of the classification of job seekers in Job Network services as at 9 March 2007. This information is not available for 2007-08. The reduction to the administered appropriation for 2007-08, which appears on page 13 of the Portfolio Additional Estimates Statements 2006-07, is based on modelling of overall Job Network costs and does not involve a calculation of future point in time caseloads. Access to the Job Network service is demand driven and actual expenditure is determined by eligible job seekers and associated job outcome payments and other elements of the appropriation.

Estimated cost: Using the FOI calculator, to prepare this answer it has taken approximately 7.5 hours at an estimated cost of \$150.
