### **EMPLOYMENT PATHWAYS PLANS**

Please provide the latest available data on the breakdown of Employment Pathway Plans for early school leavers on Youth Allowance (Other) by age (16-17yrs, 18-20yrs), type of activity and numbers participating in each (including data on those exempted from requirements), and the number of early school leavers on YA(O) in each of those age brackets?

### Answer

Type of activities contained in Employment Pathway Plans for Early School Leavers receiving Youth Allowance (other), for recipients aged under 18 and 18-20.

- Youth Allowance (Other) recipients can satisfy their Early School Leaver participation requirements by participating in Job Services Australia Stream 4 or Disability Employment Services.

Programs Early School Leavers with an Employment Pathway Plan that included participation in a suitable program, such as the Adult Migrant English Program, Australian Apprenticeship Access Program, Community Development Employment Project-Work Readiness Service Stream, Language, Literacy and Numeracy

- Program, National Green Jobs Corps, New Enterprise Incentive Scheme training, Youth Connections, or work for the dole or Green Corps activities with structured training.
- 3. Other Activities Early School Leavers with an Employment Pathway Plan that included participation in a range of different activities such as attendance at state-based programs, provider-based training, drug and alcohol counselling, relationship counselling, and/or obtaining a driver's licence.

Note: This data has been extracted so that each Early School Leaver is only counted once according to the primary service/ activity in their Employment Pathway Plan. Some Early School Leavers can fit into multiple categories above (for example, they could be participating in Stream 4 services within Job Services Australia while also undertaking some accredited study).

This data is based on recipients of Youth Allowance who were current (i.e. entitled to be paid) on the Centrelink payment system.
