Senator KIM CARR: I would like the list of the reductions and the increases for the education budget, if you would not mind, Ms Paul. Ms Paul: Yes, of course. Senator KIM CARR: By education, I do not just mean schools. Ms Paul: Okay, that is not a problem. It is a bit hard to tell from here because, of course, the former department went four ways. Senator KIM CARR: I know, but the point is that MYEFO makes it very clear though, doesn't it? Ms Paul: Yes, I think we can certainly be very clear. Senator KIM CARR: We can establish that from MYEFO, can't we? Ms Paul: Yes. Senator KIM CARR: We will work on one source document somewhere. Ms Paul: There is MYEFO and there is the PAES, so, yes, that is fine; we will do that.
