Senator Crossin and Senator Wong provided in writing 31 May 2006.

#### Question:

Please provide the amount of funding (actuals and estimates) for non-government and government schools IESIP for the following years: 2004-05, 2005-06, 2006-07 and 2007-08.

Could these figures also be provided on a calendar year basis?

#### Answer:

Indigenous Education Programme (IEP) funding

Indigenous Education Programme (IEP) funding is appropriated under Section 14A of the *Indigenous Education (Targeted Assistance) Act 2000* which allows for payments to be made over an 18 month period. The IEP funding is limited to the amounts specified in the legislation. It is comprised of a number of programme elements: Supplementary Recurrent Assistance (SRA), Targeted Projects and Programme Support, and since 1 January 2005, Indigenous Education Direct Assistance (IEDA).

SRA is distributed to government and non-government education providers on a per capita basis and will fluctuate with enrolment growth. Enrolment changes may impact on the funding available for Targeted Projects.

Funding for "Mixed-mode" Away from Base is appropriated under Section 13 of the *Indigenous Education (Targeted Assistance) Act 2000* and is demand driven.

The Indigenous Education Programmes operate across the preschool, school, vocational and technical education and higher education sectors.

The estimates and expenditure provided below relates to all of the funding appropriated under the Act and expenditure across all sectors
