*17 Moore Street Canberra, 50 Marcus Clarke Street Canberra and 39-41 Woods Street Darwin operate under a Green Lease Schedule (GLS), which requires the owner to make their best endeavours to achieve at least a 4.5 star NABERS rating for base building and DEEWR to achieve at least a 4.5 star NABERS rating for the tenancy – both within the first 12 months of operation. 39-41 Woods StreetDarwin and 50 Marcus Clarke StreetCanberra have not yet completed their initial 12 months of operation; 17 Moore StreetCanberra has and awaits a formal assessment, though recorded energy data indicates that it will achieve the required standard.

NOTES

- 1. 16-18 Mort Street was audited by Bassett Engineering (now AECOM) in 2008 but no formal NABERS rating was given.
- 2. DEEWR has examined options for retro-fitting energy saving systems (upgraded lighting, etc.) into existing leases but found them to be uneconomical within leasing timeframes. Therefore the department's energy reduction strategy focuses on:
 - improving the energy efficiency of ICT and printing equipment
 - a longer-term property strategy to reduce the number of properties leased by the department, particularly in Canberra, and to aim for energy-efficient properties (e.g. NABERS 4.5 star rating) wherever new properties are leased
 - engaging and educating staff in better work practices to reduce unnecessary energy usage.
