Question

Suspended Jobseekers That Are Exempted

Senator ABETZ: In that case I should ask: out of the suspended, how many are exempted? Ms Paul: That is what we cannot give you because we do not have it here just for JSA. Senator ABETZ: But you will provide it on notice? Ms Paul: We will provide it on notice... We will give you a nice clear table which takes that 21 per cent and just breaks down all the categories.

Answer

The table below provides a list of suspension categories for those job seekers who were on the Job Services Australia (JSA) caseload as at 31 May 2011. Identified in the table are those job seekers where the JSA caseload suspension is due to Centrelink applying an exemption from the activity test or participation requirements.

As explained in EW320_12, as at 31 May 2011 there were 759,829 job seekers in Job Services Australia. Of these, 164,576 (21.7 per cent) were suspended. Of the suspended job seekers 46,567 (28.3 per cent) had an exemption.
