Consultation with Industry re Apprenticeship Competency Based Training

Mr Maynard: We have commenced consultation with industry in relation to this particular initiative. We have met with all ISCs and with peak employer and union bodies to talk through the potential use for this. The key features that are stressed in our conversations here are that we are looking for models that will lead to sustained outcomes that are going to provide a widespread benefit and that, wherever possible, contain a co-contribution requirement. So we do not want industry to come with their hand out. We want them to be equally paid-up players in the game. Senator NASH: On notice, in as far as you can, could you supply for the committee the consultation that you have had across industry that you were just outlining.

Answer

Discussions aboutcompetency based progression through apprenticeships and traineeships, including in relation to the *Accelerated Australian Apprenticeships* initiative announced as part of the *Building Australia's Future Workforce* package in the 2011-12 Budgethave been held with a number of organisations.
