Question

Data Available On For Postgraduate Students

Senator MASON: All right. Can I also ask, Ms Paul, what data is available on completion rates for postgraduate students and also trends over time, if that is all right.

Ms Paul: Sure.

Senator MASON: And also student-staff ratios, and you will understand why I am asking this.

Ms Paul: Yes.

Senator MASON: Quality issues are clearly a big thing facing the university sector at the moment.

Ms Paul: Yes.

Senator MASON: What is the latest data available on student-staff ratios for undergraduates at Australian universities, both overall and at each institution? Now, it is a difficult question because you have to break it down by what faculty and then by department, I suppose.

Ms Paul: Yes.

Senator MASON: But that would probably take you forever.

Ms Paul: That might. We will do our best.

Answer

The Department collects data on a range of characteristics of students enrolled in higher education in Australia, including award course completion numbers. This information is publicly available

The Department has conducted a cohort analysis of completion rates for domestic postgraduate students by tracking all domestic Table A postgraduate students (full-time and part-time) from commencement in 2001 to completion (by 2009) for students who commenced in 2001 and in subsequent years to provide an overview of the outcomes at the end of 2009. The completion rates for domestic postgraduate students and the trend over time is at Attachment A, Table 1.

The latest data available on student-staff ratios is 2009. The Department collects data on student-staff ratios for all students at Australian Universities. The information on staff is not disaggregated by those who teach undergraduate and those who teach postgraduate or other courses. The overall student-staff ratio and that for each institution are at Attachment A, Table 2.

NOTES

- (1) For each cohort, postgraduate students were tracked from commencement to completion (using student ID at that institution) to provide an overview of the outcomes at the end of 2009. For example, postgraduate students who commenced in 2001 were tracked to see how many of these students had completed their studies by 2009, how many were still studying in 2009 and how many of them were not studying in 2009 and had not completed the studies which they had enrolled in and had left the institution.
- (2) Postgraduate coursework includes Postgraduate Qualifying or Preliminary (for Master's, Doctorate or Higher Doctorate), Graduate Diploma/ Postgraduate Diploma in new areas or extended existing areas.
- (3) It is not possible to track postgraduate students who moved to another institution without the CHESSN.
- (4) Data includes Domestic commencing postgraduate students in Table A universities only.
