FWO - Plans for targeted campaigns

Senator ABETZ: is the one where you fall short. So, for the sake of the record, you seem to be meeting four out of the five. Can you please take on notice the targeted campaigns, both national and state, that you have intended for 2012-13, and if you have given forward thought to 2013-14 and 2014-15—as advanced as you can go. Mr Wilson: Do you want that broken down into the regional areas as well, do you? Senator ABETZ: Yes, please, if you could. Mr Wilson: We can do that.

The Fair Work Ombudsman has provided the following response.

In the Fair Work Ombudsman's annual Portfolio Budget Statements, one of the key performance indicators is that the agency must undertake four national targeted compliance campaigns and two state-based targeted compliance campaigns in each state and territory per financial year.
