REPORT TO THE SENATE

1.1 The Employment, Workplace Relations and Education Legislation Committee presents its report to the Senate.

INTRODUCTION

1.2 On 14 May 2002 the Senate referred to the Committee the particulars of proposed Budget Estimates 2002-2003 in relation to the Employment and Workplace Relations and the Education, Science and Training portfolios.

1.3 At hearings held on 3 and 4 June 2002, Senator the Hon Ronald Boswell acted on behalf of Senator the Hon Richard Alston who was the Minister representing the Minister for Employment and Workplace Relations. The Committee heard evidence from Senator Boswell, the department and portfolio agencies on the proposed budget estimates for the Employment and Workplace Relations portfolio. The following agencies appeared before the Committee: Australian Industrial Registry; Equal Opportunity for Women in the Workplace Agency; National Occupational Health and Safety Commission, Comcare Australia, and the Office of the Employment Advocate.

1.4 Senator the Hon Judith Troeth, on 5, 6 and 7 June 2002 and Senator the Hon Helen Coonan, on 21 June 2002 acted on behalf of Senator the Hon Richard Alston, as the Minister representing the Minister for Education, Science and Training. Senator the Hon Richard Alston attended in his capacity as the Minister representing the Minister for Education, Science and Training on Friday, 21 June 2002. The Committee heard evidence from officers of the department and related agencies on the proposed budget estimates for the Education, Science and Training portfolio including the Australian Research Council; the Australian Nuclear Science and Technology Organisation; and the Commonwealth Scientific and Industrial Research Organisation and the Australian National Training Authority.

1.5 The Committee took into account the Portfolio Budget Estimates Statements 2002-2003 and corrigenda tabled provided by the departments and also their Annual Reports for 2000-2001. Review of the budget estimates expenditure for the portfolio was carried out over six days, 3, 4, 5, 6, 7 and 21 June 2002.

MINORITY REPORT BY OPPOSITION SENATORS

The purpose of the Senate Estimates process is to pursue the principle of public accountability of the administrative arm of government by scrutinising its activities. The 2002 Budget Estimates hearings of the Employment, Workplace Relations and Education Legislation Committee raised a number of serious concerns in this regard, in particular that the Government has sought to undermine the capacity of the Committee to do its work.

These go to the conduct of the Department of Education, Science and Training in responding, and failing to respond, to questions. In particular the Department entered the hearings without having provided answers to three routine questions, asked annually during the Additional Estimates round in February, on the Department's annual expenditure on consultancies, market research and advertising. The justification provided by the Department for this unprecedented failure was that it was impossible to meet the request "due to other reporting obligations of [the] Senate."

The Clerk of the Senate, Mr Harry Evans, provided the following advice on this matter:

It would be remarkable... if the information you have sought is not readily available in the department. Senior executives of the department would surely need to have this information readily available for the purpose of managing the department.

The Clerk further asserted that he was unaware of "other reporting obligations" to the Senate that might reasonably have prevented the Department from supplying answers to these questions.

It would appear, then, that the Department exhibited on this occasion an unwillingness to cooperate in the legitimate accountability process of the Estimates Committee. Furthermore, as the Clerk noted, it would seem that the Department did not have this basic administrative information readily to hand and up to date. This points to a grave flaw in the Department's administration and its management practices.

During the Committee hearing itself the Department, in response to questioning from Government Senators, made a series of assertions about the alleged cost to the Government of answering the Committee's questions over the life of the current and the immediately previous Parliaments. It implied that this cost was inordinate, and that certain members of the Committee had wasted public funds by asking unnecessary, and unnecessarily detailed, questions.

In fact the evidence provided by departmental officers revealed serious deficiencies in its management systems, especially in relation to contract and procurement management. Officers gave evidence that departmental administrative guidelines had been revised in this regard, and had been the subject of a staff circular of May 2002. It also became clear that significant alterations and improvements to the Department's consultancy database and other record-keeping had been necessary for reasons other than to meet the reporting requirements of the Senate – including requirements to provide reports to several other major other Government departments and agencies. Further, the system, with all its apparent inadequacies, had been in operation for several years without these problems being addressed. Further improvements were also necessary and were planned. It is reasonable to expect that any modern computer software of this type would have the flexibility to allow the

addition of extra fields to a database without incurring expense of the magnitude claimed by the Department necessary to meet the needs of the Committee alone.

Opposition Senators vigorously deny the charge that they have wasted public funds by deliberately asking unnecessary, frivolous or vexatious questions. On the contrary, Opposition Senators draw attention to the savings of Commonwealth monies, and the improvements to administrative practices and arrangements, resulting from investigations emanating from the Estimates Committee. Over the past several years, as a result of Senate Estimates questioning and related Parliamentary processes:

- The entire regulatory regime surrounding Australia's international education industry has been completely revamped and revised;
- Rorts associated with employer subsidies for training have been uncovered;
- Flaws in the administration of the Establishment Grants program for new non-government schools have been exposed; and
- The Government has been forced to act to review the establishment by the Government of the External Territory of Norfolk island of an internet university of doubtful provenance and reputation.

These cases are merely examples of the proper use of the Estimates Committee processes to examine the Government's conduct and practices with regard to its administrative role. In the view of Opposition Senators, the concerted and orchestrated criticisms emanating both from DEST and from Government Senators were inappropriate and regrettable.
