In the year 1 November 2005 to 31 October 2006, 4 providers have had their CRICOS registration cancelled by the Department and 26 providers' CRICOS registrations were suspended by the Department under the *Education Services for Overseas Students Act 2000* (the Act) for the reasons shown in the following table.
