Data taken from AusTender indicate the following changes to the portfolio's tenders in 2010-11:

2010-2011 (01 Jul 10 – 30 Jun 11)

DEEWR had 17 tenders with addenda. These included:

- 29 questions from respondents with DEEWR answers posted as addenda.
- 6 clarifications to documentation.
- 8 additional information addenda.
- 1 amendment to tender documentation.
- 1 addition of AusTender clause.
- 2 corrections to documentation.
- 4 changes to close dates.

Comcare had 3 tenders with addenda. These included:

- 15 questions from respondents with Comcare answers posted as addenda.
- 1 correction to tender documentation.
- 1 extension to the tender closing time.

The Office of the Fair Work Ombudsman (FWO) had 2 tenders with addenda.

These included:

• 6 questions from respondents with FWO answers posted as addenda.

The value of consultancies undertaken for the department for the current financial year is \$13,272,166.81. Details of consultancies undertaken or underway valued at \$10,000 or more are provided at Attachment A.

Details of all consultancies undertaken by portfolio agencies are provided at Attachment B.

Details of any new procurement opportunities are published in the Annual Procurement Plan (APP) on the AusTender website on 1 July each year. These are regularly updated by the department and portfolio agencies as required.

Data taken from AusTender indicate the following changes or corrections been made for any tenders advertised on to the Government Tenders website (www.tenders.gov.au) for tenders advertised this financial year:

2011-2012 (1 Jul 11 – 11 Nov 11)

DEEWR had 11 tenders with addenda. These included:

- 9 guestions from respondents with DEEWR answers posted as addenda.
- 11 clarifications to documentation.
- 1 change to a map in the tender documentation.
- 1 change to the tender close date.

Comcare had 1 tender with addenda. This included:

• 5 questions from respondents with Comcare answers posted as addenda.

The DEEWR business opportunities on the AusTender website are current. Addendums and clarifications are made in line with the requirements of the Commonwealth Procurement Guidelines (CPGs). The department complies with the reporting requirements of the CPGs.

For this calendar year DEEWR has 146 consultancy procurements conducted via an open market approach, of which 136 consultancies were undertaken using existing panel arrangements. The remaining 10 consultancies were not published on the Annual Procurement Plan (APP). Details of the 10 consultancies are provided at Attachment C. Reasons for not publishing in the APP include:

- the procurement was not planned at the time Annual Procurement Plan was published
- the method of approaching the market had not been determined at the time of publication
