Question

Newstart and Youth Allowance specific data requests

The current number of Newstart and Youth Allowance (Other) recipients on those payments continuously for 24 months or more, and projected number in 2012-13, broken down by:

- age;
- sex;
- principal carer status;
- partial work capacity status;
- Indigenous status;
- State/Territory and capital city/other within each State/Territory;
- whether completed Year 12 education or equivalent.

Answer

The following table provides data on long term (in continuous receipt of their current payment type for 24 months or more) recipients of Newstart Allowance and Youth Allowance (other) by age, gender, principal carer status, partial work capacity status, indigenous status, state/territory, capital city and whether completed Year 12 or equivalent as at 26 August 2011.

Forward estimates of the number of long term unemployment benefit recipients are not available.

The table includes recipients of Newstart Allowance and Youth Allowance (other) who, as at 26 August 2011, were current on the Department of Human Services (DHS) payment system. The population does not include recipients of the Community Development Employment Projects (CDEP) Participation Supplement or those who did not receive a payment due to their own income and/or that of their partner or parents, where applicable.

In order to protect the privacy of individuals, populations less than twenty are reported as "<20". Capital city distribution is based on the recipient's home address using the Australian Statistical Geographical Standard (ASGS) Greater Capital City Statistical Area correspondence July 2011.
