The OECD countries have specific programs in developing countries. Could you let me know what our involvement is with these programs in terms of staff and cost of these programs? What are the specific outcomes that you are looking for?

Answer

Australia is a strong supporter of the OECD's increasing dialogue and cooperation with emerging economies and developing countries, and, since 2007 particularly through its Enhanced Engagement (EE) Program with Brazil, China, India, Indonesia and South Africa. The OECD is also working to bolster its collaboration with South East Asia, as well as other regions.

Australia contributed approximately \$332,000 dollars through its 2011 assessed contributions (calendar year) to the OECD's EE program (based on the OECD's estimate of expenditure on EE program activities and Australia's share of the OECD's overall budget). Australia's Ambassador to the OECD and staff at the Delegation in Paris contribute to OECD discussions on cooperation with the EE countries, including through the External Relations Committee (which Australia chaired in 2009 and 2010), the Development Assistance Committee (DAC) – China Study Group, and the Development Centre.

In addition, Australia provided one-off funding for specific programs with the EE countries during 2010 and 2011, as follows.

Indonesia:

OECD Review of Indonesia's Education Sector - \$A 270,000

Australia is providing technical consultancy support (involving 3 AusAID staff based in Jakarta) for six months to prepare a report on Indonesia's education system. The report will be used to inform Indonesia's education policy development and implementation, as well as to provide key input to the Indonesia Education Sector Review, to be undertaken by the OECD in 2012.

OECD Review of Agricultural Policies in Indonesia - \$A 70,801

The Review will assess changes in Indonesian agriculture over the last two decades, evaluate agricultural policy reforms and provide recommendations for improving policy performance. The review is expected to be finalised by September 2012.

OECD Review of Regulatory Reform in Indonesia - \$A 243,583

The Review will look at how to enhance the capacity and improve the processes by which the Indonesian Government makes and enforces regulation, so as to attract and retain investment, improve services and raise public welfare. It will focus on the administrative and institutional arrangements for ensuring that regulations are effective and efficient. The Review is anticipated to be finalised in early 2012. As Chair of the OECD Working Party of the Trade Committee, Australia participated in an in-country OECD review of Indonesia's policies in early February 2011.

South Africa

Tax Treaty Negotiation Workshop - \$A800

Under the OECD's EE program and its Tax and Development program, the OECD aims to strengthen the capacity of developing countries to mobilise domestic resources for their development through more effective tax systems. The OECD ran a multilateral workshop organised by the South African Development Community (SADC) in Durban in April 2010. The Australian Treasury provided an instructor. Travel costs were substantially funded by SADC.

The human rights watchdog group, UN Watch, has been prevented from attending the Durban 3 racism meeting in New York. According to reports, the list of NGOs accredited to attend the event must be approved by member states. Did Australia approve the final list of NGOs attending Durban 3? The allocation will continue to be used to fund the whaling-related positions within the Department over the next two years, as well as associated international travel.

Progress in the ICJ case

Australia filed its written submissions (Memorial) with the International Court of Justice on 9 May 2011. This is in accordance with an Order from the Court, issued after Australia filed its Application Instituting Proceedings on 31 May 2010. The Court has ordered that Japan file its written submissions (Counter-Memorial) by 9 March 2012. The Court will then set the timeframes for the following steps in the process, which may include a second round of written submissions – a reply and rejoinder.

Answer

1) At each stage of the Defence White Paper's development, DFAT provided foreign policy guidance and advice, which included consultation by Defence on those elements related to disaster relief. This consultation involved the First Assistant Secretary of International Security Division, officers from relevant geographic divisions, the Assistant Secretary of Strategic Issues and Intelligence Branch as well as officers from the Defence and Strategic Policy Section. These officers routinely kept the DFAT Secretary and Deputy Secretaries informed.

DFAT's input into discussions with Defence was based on the recognition that disaster relief is not a primary driver of Defence planning, but that Defence capabilities have been, and will continue to be, useful for regional humanitarian assistance and disaster relief tasks. This is noted in the White Paper in paragraph 2.35, 'The Government's policy is that Defence will continue to provide a range of specialised capabilities on a scale and of a kind available from no other Australian agency. These capabilities can also be deployed in support of regional humanitarian assistance and disaster relief.

2) The Department provided Senator Fawcett a copy of The Terms of Reference to the Studdert Report on EAS Disaster Management on 20 October and subsequently emailed a copy of the full Studdert Report to Senator Fawcett on 21 October.

On 4 May 2011, Hamas and Fatah signed an agreement in which they agreed to form an interim government and to hold presidential and legislative elections within one year. Discussions between Hamas and Fatah on the composition of an interim government have since stalled and the terms of the agreement have not been implemented.

The terms of the reconciliation agreement make no reference to the Covenant (or Charter) of the Islamic Resistance Movement (Hamas).

The Government's position is that it would only support a reconciliation agreement between Fatah and Hamas that was fully consistent with the Middle East Quartet's principles, namely, that all members of a future Palestinian Government must be committed to non-violence, recognition of Israel, and acceptance of previous agreements and obligations, including the Quartet's 2003 Road Map.

- a) Yes.
- b) They returned to Greece. Two Australian women from that group subsequently intended to travel to Palestine as part of the "flightilla". They were detained by Israeli authorities in Tel Aviv upon their arrival by air from Athens on 12 July 2011. Both Australians were released from detention following a court hearing on 13 July and departed Israel a week later. On 12 July 2011, a consular officer from the Australian Embassy in Tel Aviv spoke to the women via telephone, immediately following notification of their detention, and subsequently visited them in detention at the airport on the same day. Consular officers also attended their court hearing on 13 July 2011. Throughout their detention in Israel, consular officers in Australia kept in regular contact with nominated family members in Australia.
- c) The travel advice for Israel, Gaza Strip and the West Bank strongly advises Australians against travelling by sea to the coast of the Gaza Strip in breach of Israeli naval restrictions or participating in any attempt to break the naval blockade. The travel bulletin 'Flotillas to Gaza' advises Australians intending to participate in flotillas should be aware that they risk arrest by the Israeli authorities, prosecution, deportation and a ban on future travel to Israel.

Answer

Yes, Australia intends to continue assistance in clearing unexploded ordnances from the Solomon Islands.

As background, Australia contributes to Explosive Ordnance Disposal (EOD) in Solomon Islands in three ways: through the Defence Cooperation Program (DCP), through the Regional Assistance Mission to Solomon Islands (RAMSI) and through Operation RENDER SAFE.

- Through the DCP, the Department of Defence is working with the United States to improve the capability of the Royal Solomon Islands Police Force EOD team. DCP funding is providing equipment and infrastructure, while Golden West Humanitarian Foundation, a US State Department contractor, provides training. The Department of Defence will continue to support EOD in Solomon Islands through the DCP in coming years.
- RAMSI provides an EOD Adviser to the RSIPF through the Participating
 Police Force (PPF). The Australian Federal Police (AFP) funds this adviser,
 who provides logistical support, liaison functions and accompanies the RSIPF
 during remote EOD operations. The AFP will continue contributing an EOD
 Adviser to the PPF if required.
- Operation RENDER SAFE is the Australian Defence Force's enduring EOD contribution to South West Pacific nations, primarily Solomon Islands, Papua New Guinea, Vanuatu, Nauru and Kiribati. Operation RENDER SAFE will continue to contribute to EOD throughout the South West Pacific, and may include future activity in Solomon Islands.

How common is forgery of Australian passports?

Answer

Forgery of an Australian passport is extremely rare. Passport forgery is defined as the counterfeit reproduction of a passport booklet or a part of the booklet, and the alteration of details within a genuine booklet, such as the manipulation of the personal biographical data or photograph.

The design and security features of Australian passports mean there are very low levels of attempted forgery. Since the release of the "N" series passport in May 2009, 4.3 million passports have been issued and only 5 attempts at forgery have been uncovered. All 5 attempts involved either the crude alteration of the data on the biographical page or the unsophisticated substitution of the biographical data page.

In addition, the worldwide introduction of ePassports has also been instrumental in preventing the fraudulent manipulation and use of passports. Australia introduced the ePassport in 2005 and to date, we know of no successful attempt to alter the data on an ePassport chip.

On 22 November 2011, China's State Council Information Office announced *China's Policies and Actions for Addressing Climate Change* White Paper, which includes a commitment to establish a carbon emissions trading market. According to Chinese media, China's State Council has approved seven pilot carbon market schemes, which are expected to commence in 2013, and be rolled-out nationally from 2015. Pilot emissions trading schemes are in operation in three Japanese regions. South Korea has been trialling an Emissions Trading Scheme since January 2010 and will commence a mandatory emissions trading scheme in 2015. In the USA, the Regional Greenhouse Gas Initiative has been in operation since 2009 and encompasses 10 north-eastern states. California will commence an emissions trading scheme in January 2012 and is also part of the Western Climate Initiative, which includes three Canadian states.

(c) Currently, DFAT advises Australians to reconsider their need to travel to Saudi Arabia due to the ongoing very high threat of terrorist attack.

DFAT continues to receive reports that terrorists are planning attacks against a range of targets, including places frequented by foreigners.

Terrorists may be planning attacks on oil infrastructure in Saudi Arabia. Attacks against oil interests have occurred in the past and could occur again in any part of Saudi Arabia. International terrorist groups continue to call for attacks against Westerners on the Arabian Peninsula, including Saudi Arabia. These include references to residential compounds, military, oil, transport and aviation interests.

The plans did not contain confidential information and were not classified; however, they were mistakenly stamped "in-confidence". This mistake was quickly identified and rectified, noting that the documents were not sensitive and did not require a security classification.
- C) It was in this context that the Secretary of the Department of Foreign Affairs and Trade, Mr Richardson, confirmed to the Senate Estimates Committee on 18 October 2010 that this was a specific error and not indicative of any systemic problem. There had been no breach of security.

- A) Australia's tobacco plain packaging (PP) bills are an agenda item for the TRIPS meeting on 24 October at the request of the Ukraine. Has DFAT obtained legal advice in relation to this development? If so, what was that advice?
- B) If any countries start a World Trade Organisation [WTO] dispute settlement procedure (DSP) regarding Australia's PP legislation, what is the likely cost to the Australian Government?
- C) Do you have one of more legal opinions on whether the Australian Government's plain packaging legislation contravenes WTO and other conventions? What do they say, who gave you the opinion(s), in what month(s) did you get the opinion(s) and what did the opinion(s) cost?
- D) Why do you believe this legislation is a justifiable exemption from Australia's international trade obligations?
- E) How much has your department spent attending and maintaining relationships and in intergovernmental organisations such as the WTO to promote the Australian foreign policy and trade agenda in the current global economic situation? Has the current economic climate led to a change in, or a different interpretation of, the guiding principles and disciplines to trade as outlined in the current Government's trade policy document of April this year, called Trading our way to more jobs and prosperity?
- F) Would the government please inform us about any debate about the PP bills in the different WTO processes?
- G) A number of international governments, organisations and think tanks have made submissions as part of the inquiries held into the Tobacco Plain Packaging Bill and accompanying TM Amendment Bill. Has DFAT spent any money on outside bodies, including legal entities, reviewing these international concerns?
- H) Has your department incurred any costs due to the international lobbying efforts of countries such as the US Government, seeking trade sanctions or any other action to persuade the Gillard Government to drop plain packaging legislation?
- The Canadian government has rejected plain packaging on the grounds that there is no supporting evidence and that the proposal will breach trade mark laws, exposing them to domestic and international claims. Has your department spent funds obtaining legal advice similar to these concerns? How much and with whom?
- J) Do you believe international trade challenges might ensue as a result of the Government's plain packaging legislation?
- K) Does your department have a budget to deal with potential international trade challenges and compensation blowouts resulting from PP? How much has the department allocated to such costs?

- L) Have you or your department spent any money holding meetings abroad regarding Australia's Plain Packaging proposal? How much?
- M) What international delegates have you met with regarding PP?
- N) Is there a cost ceiling at which point you would concede that this exercise is wasting taxpayer's money?
- O) Essentially, the Attorney-General, in 1995, encouraged Minister Carmen Lawrence to drop the plain packaging proposal due to the likely cost blowout. Don't you have the same obligation to save billions of dollars of taxpayers' money from being wasted domestically, and internationally?
- P) As a result of the Attorney-General's advice at the time, Carmen Lawrence reportedly dismissed the proposal, apparently saying, 'It is just not feasible. We would have to buy the tobacco companies trademarks, and that would cost millions of dollars.' Has your department estimated the value of tobacco companies brands? How much is the estimate?
- Q) Has your department spent any funds obtaining legal opinions regarding the Philip Morris Limited claim under the Hong Kong-Australia Bilateral Investment Treaty?
- R) If so, how much has been spent and with whom? What do these opinions speculate the cost to be in the case of such an international legal challenges?
- S) Have you or your Department, or other sections of the Federal Government begun negotiations with Philip Morris Limited?
- T) Are you aware that, in an annual survey conducted by research company Millward Brown, the tobacco brand "Marlboro" was named the world's 8th most valuable brand (ranking right up there with the likes of Apple, Google and Coca-Cola) and valued at around \$67 Billion?. That's an international worth of \$67 Billion for just one brand. What does that mean for the likely cost of compensation to tobacco companies?
- U) The World Health Organisation (WHO) considers cigarettes to be the world's most widely smuggled legal consumer product. According to WHO, sales of smuggled cigarettes will overtake legal tobacco sales by 2020. The legal trade in tobacco is worth millions of dollars annually, but will be undermined by the illegal trade. What is the Australian Government doing to reclaim any of the \$1.1billion in lost revenue caused by the illicit tobacco trade? What are you doing to protect legal trade by stopping the illegal trade?
- V) Health Department officials told the House of Representatives Health Committee in August that the amount of tobacco smuggled into Australia was small, and far less than predicted by the report by consultants, Deloittes. Since then, in one single haul, sixty tonnes of illicit tobacco was seized by Customs. Such quantities, if not found and confiscated, will undermine the legal tobacco industry. Surely, such bulk illegal imports should worry Trade officials? What is DFAT doing to assure our trade partners our internal enforcement is up to standard to protect their countries export markets in Australia?
- W) If PP is implemented, what quantities are likely to be imported illegally into Australia, and how much more revenue is expected to be lost due to the illicit trade?

Answer

- A) No. The Department of Foreign Affairs and Trade has not obtained legal advice in relation to this development.
- B) Defending any challenge would be a significant exercise. It is difficult to estimate the costs associated with any precision as it would depend on the nature of the complaint and the extent to which a WTO Member pursued it.
- C) The Department of Foreign Affairs and Trade has provided legal advice to the Department of Health and Ageing in relation to the proposed tobacco plain packaging measure. That legal advice is subject to legal professional privilege and the contents will therefore not be disclosed.
- D) Australia's international trade obligations do not prevent Australia from taking measures necessary to protect public health.
- E) The department, through its work units in Canberra, its overseas posts and its State offices, pursues an integrated foreign and trade policy agenda for the Government. This includes our engagement with a wide range of international organisations such as the World Trade Organization (WTO). Given this policy integration, the department is not able to provide accurate estimates on the costs of attending and maintaining Australia's engagement with particular organisations.
 - The current economic climate has not led to a change in, or a different interpretation of, the Government's guiding principles and disciplines to trade.
- F) Australia's proposed plain packaging measures have been the subject of recent discussion in the World Trade Organization (WTO) Council on Trade-Related Aspects of Intellectual Property Rights and the WTO Committee on Technical Barriers to Trade. Some WTO Members have raised concerns about the plain packaging legislation in these discussions. A range of other countries have expressed support for the legislation.
 - The WTO publishes minutes or summaries of its various council and committee meetings, including the Council for Trade-Related Aspects of Intellectual Property Rights and the Committee on Technical Barriers to Trade. These documents are publicly available on the WTO website at www.wto.org.
- G) No. The Department has not spent any money on outside bodies, including legal entities for this purpose.
- H) We are not aware of any countries seeking trade sanctions against Australia. The Department has not incurred any additional costs related to these matters.
- I) No. The Department has not spent any funds obtaining any such legal advice.
- J) Philip Morris Asia Limited issued a notification of claim against the Government under the Australia-Hong Kong bilateral investment treaty on 27 June and served a notice of arbitration on 21 November 2011.
- K) The Department is funded to defend international trade disputes in the World Trade Organization. The Department has not allocated specific funding to defend a dispute on plain packaging.
- L) No. The Department has not spent money holding meetings abroad regarding Australia's Plain Packaging proposal.

- M) Australia, through its diplomatic representatives, including in overseas missions, holds ongoing dialogue with a large number of countries on a broad range of trade-related issues.
 - Australia has responded to enquiries from trading partners about the proposed tobacco plain packaging measures, including meeting with all WTO delegations which have raised the measures in the WTO. Australia has used these discussions to explain the purpose and details of the proposed measures and to provide further detailed information in relation to any questions raised.
- N) This matter falls outside of the portfolio responsibilities of this agency.
- O) This matter falls outside of the portfolio responsibilities of this agency.
- P) No. The Department has not estimated the value of the tobacco companies' brands.
- Q) No. The Department has not spent funds obtaining such legal opinions.
- R) Following the Department's response to question 239, this question is not applicable.
- S) The Government has not held negotiations with Philip Morris Limited.
 Representatives from other Federal Government departments have met with representatives of Philip Morris Asia Limited in respect of its notification of claim under the Australia-Hong Kong bilateral investment treaty.
- T) The Department was not aware of that particular survey. The Department is unable to speculate on the outcome of potential legal challenges. The Government has stated publicly that no compensation will be paid to tobacco manufacturers in connection with the plain packaging measures.
- U) This matter falls outside of the portfolio responsibilities of this agency.
- V) The Department participates in the Interdepartmental Committee on Tobacco, chaired by the Department of Health and Ageing, which is coordinating Australia's participation in negotiations on a protocol on illicit trade in tobacco products under the Framework Convention on Tobacco Control.

The agenda included discussions on human rights issues and the development of a grievance mechanism. EFIC will continue to work through these issues with interested CSOs through the ongoing forum process.

Where relevant, EFIC examines human rights issues as part of its due diligence. Its checklist for the environmental and social review of transactions (available at, http://www.efic.gov.au/corp-responsibility/envr-responsibility/Pages/Procedure.aspx) provides some explanation of how this occurs.

EFIC is also participating in the continuing reviews of the OECD Recommendation on Common Approaches on the Environment and Officially Supported Export Credits and the Equator Principles. Discussions on both reviews include how each initiative should deal with human rights issues. EFIC will consider the need to further review its policy framework regarding human rights following the completion of both those reviews.

In relation to (b), EFIC is currently reviewing its existing Service Charter (available on EFIC's website at http://www.efic.gov.au/corp-
