Answer:

No one covered by the terms of the Certified Agreement (CA) is receiving remuneration in excess of the terms and conditions of the CA.

There are staff covered by the terms of the Certified Agreement who receive additional entitlements. 146 electorate staff positions and 379.7 personal staff positions are entitled to receive a benefit not prescribed in the Members of Parliament Staff (Commonwealth) Certified Agreement 2003-2006. A Determination made by the Special Minister of State, enables certain office holders (Ministers, Parliamentary Secretaries, the Leader and Deputy Leader of the Opposition in the House of Representatives and the Senate and the Leader and Deputy Leader of the Australian Democrats) to vary the terms and conditions of employment of their electorate and personal staff as set out in clause 26.7 of the Members of Parliament Staff (Commonwealth) Certified Agreement 2003-2006 (the CA). Under the Determination the office holders can appoint and advance any member of their staff to a higher salary within the relevant salary band specified in the CA.

A Determination made by the Special Minister of State under the MOP(S) Act allows staff of the Prime Minister who are below the level of senior adviser to travel in a COMCAR, in circumstances where the travel is to or from the RAAF base Fairbairn, associated with embarkation or return travel with or on behalf of the Prime Minister. There are 31.1 staff positions employed by the Prime Minister eligible for this benefit.

A Determination made by the Special Minister of State under the MOP(S) Act provides for personal staff employed by Senators and Members who are subject to a section 12 Determination to be paid additional severance benefits where their employment is terminated under section 16(3) of the MOP(S) Act as a result of the Senator or Member being dismissed or resigning. There are 92 staff covered by the Certified Agreement eligible for this benefit. They are the staff of the following:

A Determination made by the Special Minister of State enables certain office holders (Ministers, Parliamentary Secretaries, the Leader and Deputy Leader of the Opposition in the House of Representatives and the Senate and the Leader and Deputy Leader of the Australian Democrats) to appoint and advance their staff to a higher salary within the relevant salary band specified in the CA. The Prime Minister's three electorate staff positions are eligible to be appointed and moved to any salary point in the relevant band. The Prime Minister's 27.1 personal staff positions are eligible to be moved to any point in the relevant band.

A Determination made by the Special Minister of State under the MOP(S) Act allows staff of the Prime Minister who are below the level of senior adviser to travel in a COMCAR, in circumstances where the travel is to or from the RAAF base Fairbairn, associated with embarkation or return travel with or on behalf of the Prime Minister. There are 31.1 staff employed by the Prime Minister eligible for this benefit.

13 staff positions of the Prime Minister employed above the level of Adviser are employed under the terms of an Australian Workplace Agreement (AWA) and are not covered by the terms of the CA.

The Prime Minister has legislated authority under the *Members of Parliament (Staff)* Act 1984 to determine the arrangements for engaging staff. Terms and conditions of employment are established in accordance with that authority and under the Agreement making provisions of the *Workplace Relations Act 1996*.

What is the value of the total package negotiated with the Prime Minister's Chief of Staff?

Answer:

Similar to established practice in the Australian Public Service, it is not the practice to disclose the remuneration of employees under the *Members of Parliament (Staff) Act 1984* whose terms and conditions are covered by Australian Workplace Agreements, but to disclose the ranges applicable to classification levels.

The salary band for Principal Advisers is \$125,000 to \$181,200 per annum. This amount does not include employer provided superannuation payments, Ministerial Staff Allowance of \$14,800 per annum and a private plated vehicle or cash in lieu of a private plated vehicle of \$18,540 per annum.

The budget for maintenance in the Ministerial Wing at Parliament House for which Ministerial and Parliamentary Services has responsibility, is \$20,200 for the 2004-2005 financial year. The Ministerial Wing maintenance budget for both the 2003-2004 and the 2002-2003 financial years was also \$20,200. Ministerial and Parliamentary Services uses this budget to maintain the furniture that it provides in the Ministerial Wing. It is also used to pay for security escorts to facilitate after hours access to Ministerial suites. The Department of Parliamentary Services undertakes the majority of maintenance work in the Ministerial Wing at Parliament House and meets the cost of work that it arranges.

The maintenance of ministerial offices outside Parliament House is met from a broader budget covering all 246 Senators and Members' offices outside Parliament House. \$745,928 was budgeted for all Senators and Members' offices in the 2004-2005 financial year, \$720,923 in the 2003-2004 financial year and \$798,690 in the 2002-2003 financial year. There is no amount that is specifically allocated within that budget for Ministers' offices outside of Parliament House.
