As at March 2005, the Division is not participating in any IDCs involving Human Services, Centrelink or the CSA.

7. Please describe the role of these IDCs.

**Answer:** The role of these IDCs is to develop policy advice for government in relation to forthcoming negotiations with States and Territories on these programmes.

8. Did Social Policy Division have a role in determining the revised Departmental arrangements that have applied since the election in respect of FaCS/Human Services/DEWR/DEST? What was the nature of that role?

**Answer:** Social Policy Division contributed to the formulation of advice to the Prime Minister on changes to administrative arrangements following the election.

**Answer:** The administrative changes following the election were a decision of the Prime Minister. The reason for these changes were outlined by the Prime Minister in his press release of 22<sup>nd</sup> October 2004.
