- (b) In relation to question F8 [May 2007], please indicate (where a report has not been certified) if in any instances the report concerned is disputed by the Senator or Member, and has not been certified for that reason.
- (c) In relation to question F5 [May 2007] (where a report has not been certified) please indicate what efforts have been made to get any Senator or Member to certify their reports.

**Note for 7a to 7c:** Senator Murray gave further directions to officials during the FPA Committee's 19 February 2008 hearing. [Hansard, 19 February 2008, p. 113.]

Senator MURRAY—May I make it clear that my approach is not to name and shame. I am quite happy for you to pre-advise people that there is a time period before which you are going to provide us with questions and answers, and if they have certified by then, of course, they will not appear in the answer. Let me make it clear: there are only two names for 2003-04 and neither of those are on for that reason, and there are only four names for 2004-05. So really when I am talking naming and shaming, I am talking about 2006-07, which is under the new system. My memory is that it is around 2004-05 that the system was changed.

(d) Please outline what briefing or training has been provided to new members concerning their management reports and certification thereof.
