Ms Belcher—Just one moment; I will check.

Senator RONALDSON—Thank you.

Senator MINCHIN—...Senator Abetz is also right to say that what has intervened since that episode is the case of the challenge to the result in Ms Bailey's electorate, in that we now have the party of which Senator Faulkner is president challenging the behaviour and conduct of the AEC, of which he is the minister responsible, before the Court of Disputed Returns, which, frankly, I think requires an answer from the Prime Minister...Could we perhaps leave this as a question to Senator Evans, representing Mr Rudd, as to his view of what now emerges

as, from the point of view of members of this committee, the quite extraordinary and difficult situation that Senator Faulkner has been placed in as a result of the court case which has arisen post the correspondence to which Senator Evans properly referred. You can take it on notice—we understand that—because it is a very serious issue...

Senator Chris Evans—I would appreciate the opportunity to answer Senator Minchin's question and show him due respect. Senator Minchin, I appreciate the question put to me. As I said, I have complete confidence in Senator Faulkner and his independence. I am sure in terms of that matter he will handle himself in the way he always have.

In terms of concern that may have arisen since, there seemed to be cross-party agreement that no conflict arose. I will ask the Prime Minister if he has anything further to say. I think the key here is that Senator Faulkner sought the appropriate advice. He also sought to consult to make sure the process was totally transparent, and that those who may have concerns about it were consulted—that is, the Liberal Party and the leader of the coalition opposition. He received, as I understand it, feedback that they were comfortable with that. I will check those comments and make sure I am absolutely factually correct. I will come back as soon as I can with that detail...I will take your question of notice, Senator Minchin.

Mr McPhee—Thank you, Senator Minchin. The report was an important and very significant one. The legislation under which I operate requires me to table records 'as soon as practicable'. As you would know very well, the caretaker convention is a convention mainly focused on the current government not committing the next government to any sort of particular courses of action et cetera. Historically the office has tabled records during the caretaker period. We had in fact, I think, tabled two reports, even in this caretaker period, prior to the Regional Partnerships report—but going back in time we had also tabled reports in that particular period.

Senator MINCHIN—Could you take it on notice perhaps to supply to the committee the evidence of that?

Mr McPhee—Do you mean the details?

Senator MINCHIN—Yes.
