Correction: Additional Estimates Hearing on 14 February 2012

I am writing in relation to the appearance of the Department of Finance and Deregulation (Finance) before the Committee on Tuesday, 14 February 2012. At the beginning of the consideration of Outcome 3 (Ministerial and Parliamentary Services), Senator Scott Ryan asked the Department (Hansard reference page F&PA 70) This is the normal point where a series of ministerial staffing arrangements are tabled. I will give the officers time to do so.

Three sets of documents were tabled by Finance, one of which was titled, *Personal Classifications – 1 February 2012*. Under the Government heading in the document it stated that as at 1 February 2012 there were 20 Government Staff with personal classifications and provided a table listing the offices where the staff were located.

Since the hearing on 14 February 2012, Finance has been advised of the allocation of additional personal classifications to Government Staff with a date of effect prior to 1 February 2012. As a result of the receipt by Finance of this additional information, the staffing information provided by Finance in relation to Personal Classifications at the hearing on 14 February 2012 requires updating. Accordingly, a revised *Personal Classifications – 1 February 2012* is attached to this letter.
