- Prior to 1 November 2010, PM&C issued guidelines to all agencies on the operation of the FOI Act. The guidelines are available on the PM&C website.
- Since 1 November 2010 the Office of the Australian Information Commissioner (OAIC) has issued guidelines under s 93A of the *Freedom of Information Act 1982*.

Of these, 182 requests were granted in full, five partially granted, six were denied, nine requests were withdrawn by the applicant and one request was still under consideration as at 30 June 2010. As outlined in the Commissioner for Superannuation 2010-11 Annual Report, ComSuper

- received 198 FOI requests for that year. Of these, 181 requests were granted in full, six partially granted, eight were denied and three requests were withdrawn by the applicant. In 2009-10, all requests were processed within the prescribed time limits. In 2010-11 resolution of one request (since completed) took longer than the prescribed time.
- e) ComSuper received 79 FOI between 1 July 2011 and 31 January 2012. Of these, 70 requests were granted in full, four partially granted, three were denied, one request was withdrawn and one request was outstanding at that date. All requests were processed within the prescribed time limits.
