Other functions include wide range of people management and workforce planning issues, development and leadership services, capability building, Australian Public Service (APS) wide training and career development, providing advice and assistance on public service matters to agencies, supporting the SES, advises on ethics and integrity in the APS.
3. The Commission is co-located with the Department of Education, Employment and Workplaces Relations (DEEWR) in Brisbane and Melbourne and with the Fair Work Building & Construction (FWBC) in Adelaide and Perth. A fee of \$10,250 per annum per full time equivalent (FTE) is paid to DEEWR and FWBC for office occupation inclusive of related utility service charges, routine maintenance and building security services.
