8. Is the Department/Agency planning on reducing any of its spending on these items? If so, how will reductions be achieved?

#### **Answer:**

- 1. Refer to PM 227.
- 2. The Prime Minister's official hospitality is provided through administered funding appropriated for State Occasions and Official Visits and Ceremonial Hospitality. Other less significant hospitality undertaken by portfolio ministers is funded from departmental funds. No departmental hospitality costs for portfolio ministers have been incurred for the period 1 November 2014 to 31 January 2014. For the costs, refer to PM 227.
- 3. In the rare case that entertainment costs are incurred by PM&C the costs are not recorded separately from official hospitality.
- 4. Entertainment provided at official functions hosted by the Prime Minister is provided through funding appropriated for CERHOS. For the period 1 November 2013 to 31 January 2014, the entertainment spend was \$1,700.00 (GST inclusive) for a reception to celebrate Australia Day.
- 5 to 8. PM&C does not allocate budget specifically for official hospitality and entertainment. As events are identified, they are costed and paid from the existing PM&C budget or the existing State Occasions and Official Visits budget.
