I would particularly like to have an understanding of the geographic spread of those recipients.

Ms Steele: We can do that, but we do not tend to give grants to individuals. For example, we have funded the YWCA to provide some leadership training for young women. That is a national sort of thing.

Senator McKENZIE: That is fine, but just a geographic spread.

Ms Steele: Yes, we can do that.

Senator McKENZIE: Would you like to take that on notice?

Ms Steele: Can we take it on notice so I can get it right.

Senator McKENZIE: No worries.

Ms Steele: Thank you.

Senator McKENZIE: While you are doing that, could we also have an understanding of organisations—or individuals—that receive regular grants—that is, we are continuing to fund their programs for more than two years in a row. I will put the rest on notice.
