2. There are a number of official residence staff attached to The Lodge. How many staff are currently employed to work at The Lodge.

- a. How many staff?
- b. What are the levels of their classification?
- c. What is the current status of their employment?
- d. What employment contracts, agreements or awards cover these staff?
- e. What is the total annual staff bill for The Lodge?

3. Whilst The Lodge is under repair what are the staff employed to work at The Lodge doing?

a. Have they been reassigned, if so, where?

4. How many staff are engaged to service the Prime Minister's Office dining room in its capacity as the official residence dining room?

- c. What is the current status of their employment?

d. Please breakdown each of the tasks or category of tasks that each staff member employed for the PMO Dining Room perform.

5. Where are food and drinks prepared for the purpose of official functions held in the PMO dining room acting in place of the official residence?

a. What contracts were put in place for the provision of the food and beverages for official functions?

b. How does this differ to arrangements or contracts put in place for The Lodge?

c. What were the costs associated with establishing those contracts?

6. What works were required to be done to the Prime Minister's office kitchen (or other location) to bring the facility to a standard appropriate for official functions?

a. Were new ovens, cooking, cleaning or other equipment required to be installed in the Prime Minister's office or elsewhere in Parliament House to prepare, serve and clean from official functions held in the PMO Dining Room?

#### Answer:

1 Yes.

2-4 There are no Official Establishments' staff working in The Lodge while the remedial building works are being undertaken. They have been reassigned to support the Prime Minister's accommodation at the Australian Federal Police college and the dining room in the Prime Minister's Office. The three employees (2.8 full-time equivalent positions) are employed by the Department of the Prime Minister and Cabinet (PM&C) under the *Members of Parliament (Staff) Act 1984* (the Act) to undertake a range of support activities in the Official Establishments consistent with longstanding arrangements. PM&C determines terms and conditions for staff of the Official Establishments under the Act.

These employees, first employed by the previous government, are:

- the manager (employed since 2010)
- a chef (employed since 2008), and
- a house attendant (employed since 2012).

The Official Establishments (Lodge) staff prepare and serve meals in the Prime Minister's dining room for the Prime Minister, for small official functions and for private working dinners. Casual staff are engaged to assist in this preparation and service as the need arises.

The total cost of staff (including casual employees) engaged to provide the services described above is \$155,309.85 (including superannuation contributions and leave entitlements) for the period 1 October 2013 to 28 February 2014.
