Question:

1. Has the Prime Minister approved any travel by officials in this Department valued at over \$20,000? If so, please provide details.

2. Has the Prime Minister been consulted by Ministers on proposed travel by officials valued at more than \$50,000? If so, please provide details.

3. Has the Prime Minister directed departmental secretaries and agency heads to approve all other travel by departmental officials?

4. If so, has the Secretary of the Department of the Prime Minister and Cabinet approved all travel by officials in this department since the Prime Minister issued his directive? Please explain how the process is administered.

5. Have any exemptions from the travel approval arrangements been granted? If so, can details be provided, by agency.

Answer:

1. Yes. Details of overseas travel by officials of the Department of the Prime Minister and Cabinet valued at more than \$20,000 between 19 November 2013 and 28 February 2014 are provided at <u>Attachment A</u>.

2. Yes. Details of overseas travel by officials valued at more than \$50,000 between 19 November 2013 and 28 February 2014 on which the Prime Minister was consulted by ministers are provided at <u>Attachment B</u>. This does not include details relating to travel considered exempt from the approvals process, proposals that were subsequently withdrawn or travel after 28 February 2014.

3. On 18 November 2013, the Prime Minister wrote to ministers noting that overseas travel by departmental or agency officials under \$20,000 should remain a matter for secretaries and agency heads.
