1. Please provide an itemised breakdown of all costs for capital works, maintenance, acquisitions and contracted services at the official residences of the Governor-General and the Prime Minister since 31 January 2006.

2. Please provide detail of any expenses over \$5000, paid for with public funds, incurred in facilities provided by the Commonwealth to former Governor-Generals since 31 January 2006. Please indicate the nature of the expense, the cost and relevant former Governor-General.

Since 31 January 2006, none of the former Governors-General have incurred an individual expense over \$5,000.

3. Please provide a breakdown of all entertainment costs (stating the date, nature and purpose of the event, and cost of goods and services, broken down by type) paid for with public funds at the official residences of the Prime Minister since 31 January 2006.

In keeping with past practice (including that of previous governments) the costs for individual functions held at The Lodge and Kirribilli House are not generally disclosed. The functions are held in accordance with entitlements and the Prime Minister personally meets the cost of any significant hospitality at the residences which is essentially of a private or family nature.

4. Please provide details of all costs borne by the Commonwealth for Prime Ministerial overseas travel since 31 January 2006. Please indicate the visit in question and breakdown costs in categories including but not limited to transport, accommodation, food and beverages, gifts and entertainment. Please also indicate the number of staff travelling with the Prime Minister and provide a similar breakdown of costs incurred by those staff.

Costs for the Prime Minister's visit to India in March 2006 and to the United States, Canada and Ireland in May 2006 have not yet been acquitted. When all costs have been acquitted, the full cost will be available in the usual manner.
