Senator Fierravanti-Wells asked: Please provide details of the parameters which are available to charities to utilise Kirribilli House including costs, insurance, and other relevant expenses to be incurred in relation to such hiring.

**Answer:** Kirribilli House is being made available to charities for fundraising purposes. The types of functions envisaged include open days, receptions, dinners and garden tours, however all reasonable requests for use of the residence will be considered.

The use of Kirribilli House will be free of charge, however charities will be liable to pay for any additional costs incurred by the Commonwealth as a result of the function. This could include any additional security, cleaning, catering and equipment hire. Costs will be dependent on the type of function. Charities are also required to have an appropriate level of public liability insurance.
