I understand that 50 out of the 337 ministerial personal staff are in the Prime Minister's office. Mr Tune, in the last decade has there been a higher percentage of ministerial personal staff in the PM's office that you are aware of?

Answer:

The following table provides snapshots between 1 July 2000 and 1 May 2010 of the Ministerial positions allocated to the relevant Prime Minister's office as a percentage of the total Ministerial positions.

It shows that:

- At 1 May 2010, the Hon Kevin Rudd MP, Prime Minister had 50 out of 368 Ministerial staff positions (13.59%) allocated to him;
- At 23 November 2007 the Hon John Howard MP, Prime Minister had 50.3 out of 467.9 (10.75%) Ministerial staff positions allocated to him. While this represents a lower percentage of Ministerial staff positions than for Mr Rudd, this is because the total number of Ministerial staff positions declined from 467.9 in November 2007 to 368 in May 2010.
