- a) Finance entered into 498 consultancy contracts and the total value of contracts awarded was \$41.4m.

Total expenditure for the period 1 July 2007 to 27 May 2010 was \$45.9m.¹ Details of these contracts, including subject, duration, cost, and method of procurement are at Attachment A.

2008-09

The total value of contracts awarded was \$29.6m. Total expenditure on consultancy contracts was \$22.9m.

2009-10

The total value of contracts awarded between 1 July 2009 and 27 May 2010 was \$5.4m. Total expenditure on consultancy contracts was \$10.8m.

- b) Finance is up to date in meeting its reporting requirements as outlined in *Guidance in Procurement Publishing Obligations 2007*. The amounts on the AusTender website are correct.
- c) The Finance Annual Procurement Plan (APP) details planned procurements, including consultancies, for the forthcoming financial year. Finance's APP is available on the AusTender website—www.tenders.gov.au.
