Explanation of Procurement Methods

Direct Source: one of or more suppliers who are invited to make submissions under the exemption conditions of clause 8.33 of the CPGs

Select Source: where a number of potential suppliers are invited to make submissions as a result of a non-discriminatory process such as a multi-use list; or from a list of respondents resulting from an expression of interest; or who comply with a specific requirement, which requirement is essential to the conduct of the procurement

Open Source: An opportunity for any potential supplier to bid through an open approach to the market.

Panel: An arrangement under which a number of suppliers, usually selected through a single procurement process, may each supply services to DPS as specified in the panel arrangements. This category includes standing offers and supplier panels where the consultant offers to supply services for a pre-determined length of time, usually at a pre-arranged price/rate.
