## Department of Regional Australia, Regional Development and Local Government Budget Estimates 25 May 2011

#### Answer:

- The Commonwealth Property Management Guidelines require Departments to:
  - a) undertake Property Data Collection (PRODAC) reporting;
  - b) have a property management plan in place; and
  - c) have a target of 16.00m<sup>2</sup> per work point.

The Department of Regional Australia, Regional Development and Local Government (DRARDLG) was established on 14 September 2010 and its principal offices are located in Canberra and are provided by the Department of Infrastructure and Transport under shared service arrangements. The offices came with existing furniture fit out which was put in place prior to the introduction of the PRODAC reporting requirements and the Department of Finance and Deregulation target of  $16m^2$ . DRARDLG has complied with the reporting and planning requirements detailed in the Commonwealth Property Management Guidelines (the Guidelines). The space allocation in the Canberra office is  $19.45m^2$  per work point.

- I. Not applicable.
- II. No refurbishment has been undertaken by DRADLG in its nine months of operation.
  - a. No funding has been taken from the Department because it did not meet the Guidelines.
  - b. The Department is currently reviewing its future accommodation requirements and will include strategies to meet the Guidelines.

Note: In accordance with the Department of Finance and Deregulation rules, agencies are to report occupancy where the agency leases or owns 500m<sup>2</sup> or more of 'usable office area' within a building. DRADLG office holding elsewhere in Australia are less than 500m<sup>2</sup> of 'usable office area' and are therefore not part of the agency PRODAC reporting.
