
RECENT TRENDS


The following data shows trends and comparisons in the activities of Senate committees:


- The 42nd parliament experienced an increase in the total number of matters referred to standing committees, increasing from 234 in the 41st to 309 in the 42nd. So far in the 43rd Parliament (at 30 April 2012) there have been 170 matters referred. This compares to 192 matters referred after a similar period in the 42nd parliament and 130 in the 41st parliament.
- The 42nd parliament also experienced an increase in the total number of committee reports tabled, rising from 396 in the 41st to 493 in the 42nd. Committee reports tabled thus far in the 43rd Parliament (at 30 April 2012) total 253. This compares to 282 reports tabled after a similar period in the 42nd parliament and 201 in the 41st parliament.
- The busiest committees at any one time during the 42nd parliament were Economics (maximum of 14 references at one time) and Community Affairs (maximum of 14 references at one time). In the 43rd parliament, the Legal and Constitutional Affairs Committees have twice dealt with a maximum of 12 references at one time (in November 2010 and May 2011).
- Thus far in calendar year 2012, the Rural and Regional Affairs and Transport committees have tabled 10 reports and the Legal and Constitutional Affairs committees have tabled 7 reports.
- Currently, two select committees administered by the Senate are in operation (one Senate select committee and one joint select committee).


Staffing: the committee office FTE staffing level as at 30 April 2012 was 61. Recruitment is currently taking place to select a Principal Research Officer (PEL 1). This is both for planning purposes and to fill one vacancy at this level.

Cost of running Senate committee (budget 2011-12): operational costs for the Committee Office are not expected to exceed the notional allocation of \$7.19m. The attached financial summaries include the break-down of costs incurred 'by committee' for the four years 2008-09 to 2011-12 (note that 2011-12 financial information includes projections to 30 June 2012 taken at 30 April 2012).












