On 30 May 2012, information was received about proposed further changes to non-campaign recruitment advertising.

The draft executive government instruction is not directly relevant to parliamentary departments who are not subject to such directions, however, this type of advice is often used as a guide to changes in practices.

Answer

No advice about advertising has been received.

5. Did the Advertising comply with the Guidelines on Information and Advertising Campaigns by Australian Government Departments and Agencies? Provide the details for each advertising item.

Answer

As a parliamentary department (and not part of the executive government), the Guidelines are not always applicable to the Senate Department. However, the following details about recruitment advertising are provided for completeness:

Black Rod's Office – Production Supervisor - \$508.73 – arranged through Adcorp, advertised on APSJobs.gov.au, advertised in an online media forum and advertised in The Canberra Times (mono). This was not advertised in a whole-of-government composite advertisement as the position was for an Australian Parliamentary Service position. Advice was provided to the Secretary of the Department of Finance and Deregulation prior to the commencement of the Recruitment Advertising guidelines referring to the application of the guidelines to the parliamentary departments.

Committee Office – Administrative Officer – arranged through Adcorp, advertised on APSJob.gov.au, advertised in an online media forum.

Procedure Office – Casual Parliamentary Educator – arranged through Adcorp, advertised on APSJob.gov.au, advertised in an online media forum.

Committee Office – Senior Research Officer – arranged through Adcorp, advertised on APSJob.gov.au, advertised in an online media forum.

Procedure Office – Publishing Manager – arranged through Adcorp, advertised on APSJob.gov.au, advertised in an online media forum.
