Senator FAULKNER: Yes, and I appreciate that. My question went to officials. I acknowledge that of course ministerial staff are in a different position, as are members of parliament. What Senator Evans says I recall to be correct, too. I think at least two members of the current parliament have visited the coach in its development, and that is a matter of record and they have had their photographs taken there. So it is not a matter of any uncertainty or controversy. But I do say to you, Senator Sinodinos, that I am not dealing with the characters of individuals here. I am dealing with the facts. The facts are as I have outlined them. My concern remains the nature of the expenditure of nearly a quarter of a million dollars, \$245,000, to be precise, during the life of the Howard government. I have expressed those concerns previously. I will not go back there, but perhaps Senator Sinodinos away from the committee can reflect on that as an example of appropriate governance or otherwise and appropriate expenditure or otherwise in the circumstances. An 80th birthday present for Her Majesty now that she has already celebrated her 86th birthday strains credulity to say the least.

One thing that might be helpful in this regard, so we can have full clarity and revisit this issue at the next estimates round, I ask the department to take on notice the question of any other correspondence on this matter prior to the current government coming to office. I do not expect you to answer that now, but I ask officials and the minister to reflect on that. That might also assists Senator Sinodinos' reflections on this matter.
