Senator Crossin asked: Is there a national peak body for domestic violence services across Australia? If so, is it funded by the Commonwealth Government and if so, where from?

Answer: The Women's Services Network (WESNET) is a national organisation that provides advocacy on behalf of approximately 400 member organisations that are predominantly Supported Accommodation Assistance Program crisis accommodation services. There are also a number of other services and bodies that focus on domestic violence that are not members of WESNET.

The Australian Federation of Homeless Organisations (AFHO) is the peak organisation that is funded by the Commonwealth Department of Family and Community Services through the National Secretariats Program to represent the needs of people who are homeless including women and children escaping domestic violence. AFHO received \$250,000 from the Commonwealth in 2001-2002 to support its activities. WESNET is a member of AFHO and receives a contribution from AFHO for the contributions it makes to the national body.

Senator Crossin asked: If not, how does the Commonwealth Government receive input and consult with service providers working with men, women and children on domestic violence?

Answer: There are a wide range of service providers and stakeholders across the domestic violence area and *Partnerships Against Domestic Violence* (PADV) consulted across these stakeholders. WESNET was contracted to undertake community consultations which fed into the first phase of PADV. This role was part of the consultancy with the Department of Family and Community Services for PADV. Many PADV projects across both phases have inbuilt consultation mechanisms, for example the national consultations being undertaken by Health Outcomes International for the Improving Women's Safety project under the perpetrators priority area.

In addition to the above processes, the PADV initiative accesses Commonwealth, State and Territory government consultation mechanisms. The Commonwealth Government addresses domestic violence issues through the Department of Family and Community Services (men's relationship issues, family relationship issues, young people's issues, crisis accommodation issues); the Department of the Transport and Regional Services (regional services, regional women's issues, the Regional Women's Advisory Group); the Attorney-General's Department (legal aid issues, family mediation services, model domestic violence legislation); and the Department of Immigration and Multicultural and Indigenous Affairs (multicultural and Indigenous affairs). Each element of the Commonwealth's system addressing domestic violence has different consultation mechanisms.
