Senator Faulkner asked: What was the total cost of security works undertaken on Kirribilli House in the period 1 March 1996 to 1 March 1999 inclusive?

Answer: In response to parliamentary question No. 976 of 11 May 1999, the department advised that, for the period 1 March 1996 to 10 May 1999, \$89,323.50 was spent on security works and maintenance at Kirribilli House and \$497,541.25 was spent on combined perimeter security works and maintenance for Kirribilli House and Admiralty House. These figures were provided by the Protective Security Coordination Centre (PSCC). The PSCC has advised that it will take significant resources to extract the data for the period 1 March 1999 to 10 May 1999. Work has commenced and the details will be provided in due course.

These figures were provided by the Protective Security Coordination Centre (PSCC). The PSCC has advised that it would take significant resources to extract the data for the period 1 March 1999 to 10 May 1999. Work has commenced and the details will be provided in due course.
