Senator Forshaw asked:

Can the Department report the level at which government departments' air travel is undertaken using Virgin Blue and Regional Express – currently, in the last 6 and 12 months.

Answer:

In July 2003, the Government announced that the Australian Government would work towards the objective of 10 percent of government travel on the Canberra-Sydney route going to smaller airlines and that departments and agencies would be required to report regularly to the Secretary of the Department of the Prime Minister and Cabinet on their performance against the objective.

Data has been collected since July to enable performance against the Government's objective to be measured. Data on the use of smaller airlines across all domestic sectors has also been collected for comparison purposes, as has data on the use of smaller airlines for the period January to June 2003. The data for January to June 2003 only identified use of smaller airlines on all domestic sectors. No data has been collected for the period before January 2003.

The aggregate data for the months January to October is set out in the table below.
