- 8. The AVO conducted all reviews in 2002-03, 2003-04, 2004-05 and 2005-06 (to date).
- 9. Centrelink obtains a number of valuation services from the AVO. It is not possible to provide separate figures in relation to this activity.
- 10. Yes. The level of activity has now been spread more evenly across the full financial year.
- 11. Centrelink and policy departments are developing policy and procedures to ensure real estate holdings are more regularly reviewed.
- 12. A valuation that is higher than a previous valuation or a customer's estimate applies from the first pension payday after it is received.
- 13. The *Social Security (Administration) Act 1999* does not specifically provide for a transition period following the assessment of the value of properties.
