Senator Ronaldson asked:

Can you also provide the committee with a breakdown of personal staff and DLO staff that have commenced and ceased employment from 5 December 2007 to today's date?

Answer:

In the period 5 December 2007 to 21 October 2008, 270 MOP(S) Act employees commenced as government personal staff and 65 MOP(S) Act employees ceased employment as government personal staff. The figures include employees who were engaged on an ongoing, non-ongoing or temporary transfer basis to enable a smooth transition to government, as well as employees who were promoted/transferred from or to electorate officer positions. The figures do not include employees who were promoted/transferred from non-government personal to government personal staff positions following the election. The attached tables provide a breakdown by office and by classification.

In relation to DLOs, the question needs to be directed to each Minister as the Department of Finance and Deregulation (Finance) is only able to provide information relating to Finance DLOs in its portfolio Ministers' offices. During the period 5 December 2007 to 21 October 2008, there was one change in Finance DLO staff in the office of the Minister for Finance and Deregulation.


