- n) How can this committee have cabinet status if it is not a cabinet subcommittee as highlighted by PM Gillard in the following quote she made in the transcript of Press Conference on October 7:

JOURNALIST: There has been criticism that the Climate Change Committee is shrouded in secrecy, how much information will you be releasing, after each meeting, in the Communiqué? Will it be substantial information or it will it basically be housekeeping?

PM: Well, I think we should be very clear about this, and I do want to be very clear. The Multi-Party Climate Change Committee is going to work in a manner comparable to a cabinet sub-committee. It is not a cabinet sub-committee but it will work in a comparable manner. That means, of course, that outcomes from the Committee will be publically announced. The Committee, from time to time, will choose to publish work for the public to digest but discussions in the room will be confidential.

- b) The Committee has agreed to meet regularly, usually monthly, until the end of 2011 at which time the ongoing need for the Committee will be considered.
- c) Item 12 of the Committee Terms of Reference indicate the Committee would generally meet in the Cabinet Room at Parliament House.
- d) The Department of Climate Change and Energy Efficiency provides Secretariat support to the Committee with the assistance of the Department of the Prime Minister and Cabinet.

As announced by the Minister for Climate Change and Energy Efficiency, the Hon Greg Combet AM MP, and the Parliamentary Secretary for Climate Change and Energy Efficiency, the Hon Mark Dreyfus QC MP, on 9 November 2010, funding of \$5.2 million has been allocated in the 2010-11 Mid-Year Economic and Fiscal Outlook to establish the Committee and update the Garnaut Climate Change Review.

- g) The four expert advisors to the Committee will receive remuneration, including travel expenses, for their work with the Committee in accordance with Remuneration Tribunal Determination 2010/11: Remuneration and Allowances for Holders of Part-Time Public Office and Remuneration Tribunal 2004/3: Official Travel by Office Holders (as amended by Determination 2010/8).
- h) It is expected that all four expert advisors will be present at each monthly meeting, although this is a matter for the Committee to determine.
- i) Professor Ross Garnaut has been invited to update the Garnaut Climate Change Review that he published in September 2008, not to be confused with the Government's Carbon Pollution Reduction Scheme White Paper released in December 2008. The update to the Garnaut Climate Change Review is being funded out of the \$5.2 million allocated to establish the Committee.
- j) This is a matter for the consideration of the Committee.
- k) Yes. The Department of the Prime Minister and Cabinet and the Department of Climate Change and Energy Efficiency (DCCEE) will both be responsible for minute-taking. The DCCEE-based Secretariat will administer and file these minutes. The Committee agreed at the first meeting that a communiqué would be released after each meeting.
- 1) The application of the FOI Act to individual documents falling within the scope of an FOI request is a matter for consideration by each decision-maker on a case-by-case basis in accordance with the Act.
