#### Prime Minister and Cabinet Portfolio

- Some individual sport programs are provided with a car for travel to sporting facilities, sporting events, the transfer of athletes and general work related travel;
- The Active After-school Communities (AASC) program uses cars to visit sites where its programs are being run, generally in remote and less accessible areas within Australia; and
- Cars are also used for corporate activities such as security, commercial operations and the transportation of athletes who reside at the AIS.
- 4. and 5. The cost identified for each car for 2010-11 is provided in the table below. The cost of each car is based on the running costs (fuel and servicing), depreciation of the vehicle and insurance costs.
- \* Costs and kilometres travelled for these vehicles are maintained on the FBT year only. Details provided are for the FBT year ended 31 March 2011.
