

In relation to the Brisbane Women's Correctional Centre, what is the procedure in this particular instance? Is there a procedure that you contact them by telephone and say that you have a, what, for them? Do you say a person, do you say an unlawful non-citizen?

Answer.

The procedures followed are those established between DIMIA and the Queensland Department of Corrective Services, which makes provision for the accommodation of immigration detainees in Queensland correctional facilities. At the present time it is an arrangement in advance of formalisation of a new Service Level Agreement. There is no separate procedure in place between DIMIA and the Brisbane Women's Correctional Centre (BWCC).

Under this current arrangement, DIMIA would normally contact the prison and advise of the impending arrival of an immigration detainee. Where possible, DIMIA provides the facility with an estimated time of arrival and any personal details known about the detainee.

If the immigration detainee is being transferred from another place of detention, then personal property is transferred directly with the detainee. The requisite detention authorities and custody transfer documents are either provided to the facility in advance of arrival or provided at the time of arrival of the detainee at the facility.

Induction processes into the facility are those applicable to the facility.

In the case of Ms Rau (Anna Brotmeyer aka Schmidt), it was the Brisbane DIMIA office which called BWCC, requesting that they hold 'Anna Brotmeyer' aka 'Anna Schmidt (21.03.1970)', as she was known or reasonably suspected to be an unlawful non-citizen. The request was made by both the telephone and formally in a facsimile.

A DIMIA officer in Cairns undertook searches on departmental databases. During one of these searches a person with a name similar to *Anna Brotmeyer* was identified as a lawful non-citizen.

Enquiries were then conducted to establish whether Ms Rau (Anna Brotmeyer aka Schmidt) was the registered visa holder. The person identified on the Department's database was contacted by telephone and her identity was established.

A passport was found in Ms Rau's (Anna Brotmeyer aka Schmidt) possession. The owner of the passport was contacted and claimed she had no knowledge of Ms Rau (Anna Brotmeyer aka Schmidt) or a person of her description.

Three officials from DIMIA's Brisbane Office visited the Brisbane Women's Correctional Centre (BWCC) on 30 September 2004. The purpose of the visit was to both introduce two of the DIMIA officials to staff at the facility and to Ms Brotmeyer, who was detained at the facility for immigration purposes, as the DIMIA officer formerly responsible for her case was transferring inter-state.

The three DIMIA officials spoke with Ms Brotmeyer and advised that as the Department had not yet been able to confirm her identify or immigration status, arrangements were being made for her transfer to the Baxter Immigration Detention Facility (IDF) where these efforts would continue.

Ms Brotmeyer was again asked whether she could provide any further information to assist in establishing her identity or immigration status.

The consent of the person concerned is not required for such a transfer. Nevertheless, DIMIA officers sought Ms Brotmeyer's cooperation in the transfer, explaining that Baxter IDF was a better facility for managing the needs of longer term immigration detainees. Ms Brotmeyer advised she would prefer to remain at the BWCC and refused to sign the 'notice of intention to transfer' to acknowledge that she was advised of the planned transfer.

In this instance, what was communicated precisely to DIMIA? What did DIMIA request in relation to the health and wellbeing of Cornelia Rau whilst in detention? It seems that Ms Rau spent some time with the health authorities that were provided by the correctional services department and with another hospital to which she had been transferred. I want all of that detail. When was that? In other words: the file, the dates and all of that.

Answer.

DIMIA officers routinely visit the Brisbane Women's Correctional Centre (BWCC) to meet with Correctional staff, immigration detainees and to discuss general welfare associated with immigration detainees in the facility. During Ms Rau's (Anna Brotmeyer aka Schmidt) time at the BWCC there were only small numbers of women, a maximum of six, in immigration detention at any one time.

Telephone contact by DIMIA was also made on a number of occasions with BWCC to discuss the care needs of Ms Rau (Anna Brotmeyer aka Schmidt) and other female immigration detainees. Arrangements are also in place for exceptional and after hours reporting.

Ms Rau's (Anna Brotmeyer aka Schmidt) day to day needs were managed by the Queensland Correctional Services. Decisions regarding Ms Rau's (Anna Brotmeyer aka Schmidt) health needs were made by the appropriate health care professionals within the Queensland correctional facility.

On 19 May 2004, Ms Rau (Anna Brotmeyer aka Schmidt) was assessed by the BWCC psychologist who concluded "....Nil evidence of mental health illness noted or described. Nil further follow-up required by Prison Mental Health Service at this time".

Following discussions between DIMIA Brisbane and BWCC relating to her ongoing management and behaviour, Ms Rau (Anna Brotmeyer aka Schmidt) was seen by a psychiatrist at BWCC on 10 August 2004. The psychiatrist's recommendation for admission to a hospital for further assessment was facilitated by DIMIA.

Ms Rau (Anna Brotmeyer aka Schmidt) was transferred to Princess Alexandria Hospital on 20 August 2004 and returned to BWCC on 26 August 2004.

Senator Chris Evans (L&C 48) asked:

Was DIMIA asked to pay for Ms. Rau's health costs in Brisbane and, if so, did DIMIA pay?

Answer.

To date the Department has not been asked to pay for health costs in Brisbane for Ms Rau (Anna Brotmeyer aka Schmidt).

Senator Bartlett (L&C 52) asked:

Provide information on guardians that the Minister referred to and examples of that.

Answer.

There are four reported cases of immigration detainees being appointed a guardian, after entering immigration detention, by the South Australian Guardianship Board. One in March 2002; one in January 2004 and two in February 2005. To date the Board has appointed the SA Public Advocate as the Guardian.

In these cases the Department has advised the SA Guardianship Board that the exercise of authority under the South Australian Guardianship and Administration Act 1993 and/or Mental Health Act 1993 needs to be consistent with the provisions of the Migration Act. The Board is assured of the Department's willingness to work cooperatively with a Guardian to ensure that an immigration detainee's interests are protected and the Department's obligations under the Migration Act continue to be satisfied.

What was the non-government organisation in Adelaide that DIMIA had discussions with to explore whether alternative detention arrangements could be made for Ms Rau?

Senator Bartlett (L&C 58) asked:

Provide a copy of the file notes of all those conversations between DIMIA officials and South Australian health officials.

Answer.

The Department was in regular contact with the South Australian health authorities, this included Departmental officers in Canberra and Baxter IDF. This communication included telephone calls, correspondence and e-mail messages. Records are not routinely kept of all conversations.

Please note that many of the communications with the South Australian health authorities are referenced in the response provided in Question 44 to Senator Ludwig.

Senator Nettle asked:

Provide a list of the people who were detained because they were not who DIMIA believed them to be and indicate the period for which they were detained, their nationality and whether they received a settlement. Also provide details of the amount of money that has been spent as a total on both the detention and the settlements for those individuals.

Answer.

During the Senate Estimates hearings of February 2005, Mr McMahon, Executive Coordinator Border Control & Compliance Division stated that "I do not believe there was any way we (DIMIA) can get that information. We can get some information around it...".

However, we are unable to provide an answer as there is no facility in DIMIA systems to report according to identity issues. To answer the question as framed would require a manual examination of individual records and would be an unreasonable diversion of departmental resources.

Individual detention costs are not available, however the average daily detention cost for a person is estimated to be \$189.

The Department's response to QoN 114 asked by Senator Ludwig provides details of settlements.
