### **Question No. 98**

### Senator Ludwig asked the following question at the hearing on 17 February 2006:

- a) What are the operating hours of Container Examination Facilities (CEFs)?
- b) What is the average daily throughput of CEFs, broken down by port?
- c) What is the target daily throughput of CEFs?
- d) What is the average waiting time for access to a CEF?
- e) What are the same figures for 2003-04 and 2002-03?

## The answer to the honourable senator's question is as follows:

a) The CEF hours of operation are:

Sydney	0530 - 2230	0530 - 1530
Melbourne	0600 - 2230	0600 - 1430
Brisbane	0600 – 2300	0600 – 1500
Fremantle	0600 – 2200	0600 – 1400
Adelaide	0700 – 1700	Closed

#### b) and c)

The CEFs have annual throughput targets. Customs does not record the average daily throughput.

The table below outlines the annual throughput targets and actuals by port for financial year 2004-05. All figures are in twenty foot equivalent units (TEU), which is the international measure for containers.
