SENATE STANDING COMMITTEE ON LEGAL AND CONSTITUTIONAL AFFAIRS NATIONAL NATIVE TITLE TRIBUNAL

Question No. 147

Senator Fierravanti-Wells asked the following question on 13 February 2007:

- a) Recently some representative bodies have criticised the Tribunal about its mediation performance. In particular, Ron Levy, of the Northern Land Council, was very critical in his submission to the committee some two weeks ago. Could you please outline the Tribunal's response to these criticisms? A copy of the relevant transcript date 30 January 2007 is attached.
- b) Could you please provide details of any native title claims, past or present, which have been filed, considered or determined by the NNTT regarding the Illawarra region of NSW.
- c) Have any such native title claims involved the Illowra people?

The answer to the honourable senator's question is as follows:

a) The Tribunal has responded to representative bodies' criticisms about its mediation performance in a written submission to the Senate Legal and Constitutional Legislation Committee, which was lodged on Friday, 9 February 2007. The Tribunal's submission responds to submissions and evidence dealing with the capability and capacity of the Tribunal that were presented to the committee. The Tribunal's submission makes specific reference to comments made by the Principal Legal Officer of the Northern Land Council, Mr Ron Levy.

In his evidence before the Committee, Mr Levy's use of the Newcastle Waters matter to illustrate that quicker mediation outcomes are achieved by the Court than the Tribunal did not give a complete overview of progress on that matter. Mr Levy omitted to mention that the Tribunal used mediation to identify what was agreed between parties and to distil to three the critical outstanding issues in Newcastle Waters. By agreement of all the parties, the Newcastle Waters matter was taken to the Federal Court to seek a ruling in relation to the legal issues. The Tribunal's mediation allowed all parties to the matter to ventilate their concerns in a private and without prejudice setting, leading to refinement of the issues and saving considerable expense in further mediation until those issues were resolved. The Newcastle Waters matter serves as an example of the strategic interplay between the Tribunal and the Federal Court to manage a native title matter in the most efficient and effective way.

My inquiries reveal that with the exception of the Newcastle Waters matter, and in earlier times, a Miriuwung Gajerrong matter, the Northern Land Council has had limited experience of Tribunal mediation. It has sought to avoid referral of native title claimant applications to the Tribunal for mediation, or has sought to have the Court order that Tribunal mediation cease. The Northern Land Council has consistently advised that it and its clients lack resources to participate in mediation of applications that are referred to the Tribunal.

b) Below is a list of all native title claims made in relation to areas of land or waters in the Illawarra region. It should be noted the Tribunal does not determine claims,

although they are included in this list. Two maps of the region depicting active claims and inactive claims are attached.
