Senator Ludwig asked the following question at the hearing on 13 February 2007:

- a. For the years 2005-06, please indicate, not including those employed in policy functions, the number of Full-Time Equivalent positions assigned to the following areas:
 - i) The screening, holding and clearance of air cargo (not including the Torres Strait);
 - ii) The screening, holding and clearance of sea cargo (not including the Torres Strait);
 - iii) The screening and clearance of persons arriving in Australia by air (not including the Torres Strait);
 - iv) The screening and clearance of persons arriving in Australia by sea (not including the Torres Strait);
 - v) The screening, holding and clearance of post arriving in Australia;
 - vi) Coastwatch;
 - vii) The development of technology or programs designed to augment, replace or assist any of the above functions.
- b. For each of the categories in (a.), please indicate:
 - i) The breakdown of APS classifications for those personnel;
 - ii) The total wages cost of all personnel under that category;

The answer to the honourable senator's question is as follows:

The answers to questions a) i) to iv) and b) i) to ii) were derived from Customs Activity Based Costing framework. Through this system employees time is allocated to a range of activities associated with Customs operations. Not all activities in Customs Activity Based Costing framework align directly with those outlined in the question however a best match of the Customs activities to the question has been applied where necessary. Employee costs include salaries, allowances, superannuation and accrued expenses.
