Senator Barnett asked:

Ministerial Travel

- (1) Has the Minister/Parliamentary Secretary travelled overseas on official business since Budget Estimates?

 - c) any other expenses?

 - c) any other expenses?
- (6) How many officers from the Department accompanied the Minister/Parliamentary Secretary?
- (7) In relation to these Departmental officers, what was the total cost of:
 - a) travel
 - b) accommodation, and
 - c) any other expenses?

Answer.

- (1) The Minister has travelled three times since Budget Estimates in May 2008. The Parliamentary Secretary has travelled once.
- (2) The Minister travelled to:
 - Indonesia, Malaysia, Thailand and Singapore from 5 to 12 August 2008;
 - Vietnam from 11 to 14 January 2009; and
 - Indonesia from 2 to 4 March 2009.

The Parliamentary Secretary travelled to Malaysia from 8 to 11 June 2008.

Responses to questions (3) to (7) for each visit are set out below.

Minister's visit to Indonesia, Malaysia, Thailand and Singapore
