## Senator Barnett asked the following question at the hearing on 8 February 2010:

## Regarding reviews:

- a. How many reviews are currently being undertaken across the portfolio? When will each of these reviews be concluded?
- b. Which reviews have been completed since Budget Estimates? When will the Government be responding to the respective reviews that have been completed?
- c. What is the total number of reviews *both completed and ongoing* in the portfolio since November 2007? What is the estimated cost of these reviews?
- d. What further reviews are planned for the 2009-10 financial year?

### The answer to the honourable senator's question is as follows:

- a. There are currently 10 reviews<sup>1</sup> being undertaken across the portfolio, to be completed in 2010:
  - Review of the sustainability and future operation of the Australian Institute of Police Management
  - Review of Commonwealth Fraud Control Guidelines 2002
  - Review of Part 1D of the Crimes Act 1914
  - Review of Part 1B of the Crimes Act 1914
  - Inter-Agency Committee reviewing the National Capital Authority's administration of leases over diplomatic land
  - Critical Infrastructure Protection Modelling and Analysis Program
  - Statutory Review of 2003 amendments to the Copyright Act 1968
  - Review of Classification Fees
  - Inter-Governmental Committee on Planning in the ACT
