Senator Boyce (L\&CA 46) asked:
Provide the figures on the number of applicants under the Regional Sponsored Migration Scheme who are not accepted initially and the results of the appeals over the past three years.

## Answer:

Table 1 below shows the number of Regional Sponsored Migration Scheme (RSMS) visa applications that were refused from the 2008-09 program year through to the 2011-12 year to date (to 29 February 2012) program year. The figures are divided by subclass 119 (offshore visa applications) and subclass 857 (onshore visa applications).
