#### **Question No. 57**

In relation to the Christmas Island Deployment:

- 1. Can you provide an update of how many AFP officers are currently stationed at Christmas Island?
- 2. Can you provide the figures as at the first day of the month for the past six months?
- 3. Over the past six months, has the AFP had to respond to any incidents at the Immigration Detention Centre and associated facilities on Christmas Island? If yes, detail the specific dates and nature of the incident including how many people and officers involved.

## The answer to the honourable senator's question is as follows:

1. As at 27 February 2013 there are 9 members stationed at Christmas Island. Additionally 34 members were on short term deployment.
